Confidentiality

Everything that is shared between us will be kept in confidence, within the legal limits. I will not reveal anything about our work together without your permission. Please note that I do not share the same type of confidentiality protection afforded by law to a licensed therapist or a lawyer. My notes and my testimony can be subpoenaed. I am also obligated to report your intent to harm yourself or others and your intent to commit a crime or your participation in a crime.

Maintaining the Integrity of Our Coaching Relationship

The foundation of our coaching relationship is mutual trust and respect. If at any time I say or do anything that feels uncomfortable or seems inappropriate to you, please bring this to my attention immediately so that we can discuss and resolve the problem. In the unlikely situation that we cannot come to an understanding, a mutually agreed upon mediator will be used to assist us in resolving the issue.

Payment for Coaching Services and Expenses

Your fee for this coaching service is \$65.00 per session hour. In person sessions requiring air travel, will be charged for four (4) hours at a minimum. Ad hoc "spot coaching" calls cost \$20.00 per 15 minute call, with a minimum of 15 minutes per call. You will be invoiced as scheduled sessions occurs, and payment is expected before the next scheduled session. Payment may only be made by check or electronic funds transfer (Paypal, etc). You'll receive an email once I've receive payment which will serve as your receipt for tax purposes.

Travel expenses will be included on the invoice for all in person session.

Those expenses may include airfare from Lynchburg VA Regional Airport to the airport nearest to your location. Travel expenses will include taxi, hotel, and meals, when required. Receipts will be provided for all travel expenses with the invoice. Your assistance with identifying a hotel with reasonable rates convenient to our meeting location is appreciated.

Termination of Our Coaching Relationship

If you feel that you are not getting what you want or need from our coaching relationship, please discuss this with me as soon as you are aware of it so that we can adjust how we are working together to better meet your needs. Each coaching relationship is unique, reflecting the needs and desires of the client. We share a mutual responsibility to create a relationship that is satisfying and productive for both of us.

Our initial agreement will extend for eight (8) sessions and will be renewable if you desire additional coaching.
